Lisa Mathess is a Principal Consultant and Americans with Disabilities Act (ADA) Specialist for the Job Accommodation Network (JAN), the leading national source of expert guidance on workplace accommodation and disability employment issues. Lisa is a member of the JAN Leadership team and has served in a consulting role since 2011.

Lisa provides expert-level consultation to assist employers and individuals with disabilities with understanding their rights and responsibilities under the ADA, and in identifying accommodation solutions for individuals with various medical impairments, with an emphasis on motor impairments as the Motor Team Lead. As an ADA specialist, Lisa consults with employers, human resources, and legal professionals nationally on ADA compliance issues and engaging in the interactive accommodation process. She works with employers to create inclusive policies and procedures to onboard and advance career opportunities for individuals with disabilities.

Lisa earned a Master of Arts degree in Communication Studies and a Bachelor of Science degree in Business from West Virginia University.



#### Carol Miaskoff, Legal Counsel, EEOC Office of Legal Counsel

Carol R. Miaskoff was appointed Legal Counsel of the Equal Employment Opportunity Commission on June 24, 2021, by Chair Charlotte A. Burrows. As the agency's Legal Counsel, she manages the development and drafting of the Commission's regulations and guidance under the Americans with Disabilities Act, Title VII of the Civil Rights Act of 1964, the Age Discrimination in Employment Act, the Equal Pay Act, the Genetic Information Non-discrimination Act, and the Pregnant Workers Fairness Act. She also serves as in-house counsel to the Chair and oversees the agency's Freedom of Information Act program.

Ms. Miaskoff graduated from Harvard University and the George Washington University Law School, with high honors. In the community, Ms. Miaskoff has been active in the Montgomery County, MD, Mental Health Advisory Committee, and a guest lecturer at a Georgetown University undergraduate class on Women and the Law.
