PRESENTER BIOGRAPHIES



Bradley A. Anderson, District Director, EEOC Birmingham District Office

Bradley A. Anderson has devoted his professional career to educate employers on their responsibilities and workers on their rights under EEO laws. He has served as the Birmingham District Director of the U.S. Equal Employment Opportunity Commission (EEOC) since June 2018. The Birmingham District has jurisdiction over Alabama, Mississippi (except 17 northern counties) and the Florida Panhandle. Bradley is responsible for the District's enforcement, mediation, litigation and outreach programs.

Prior to joining EEOC, Bradley served at the U.S. Department of Labor, OFCCP from 1995 – 2018. From 2012 – 2018, Bradley led the largest region (Midwest) in OFCCP to enforce equal employment and affirmative action laws for companies doing business with the federal government.

Bradley graduated from Illinois Wesleyan University in 1991 with a double major in Business Administration and Spanish. He served for two years in the U.S. Peace Corps as a Small Business Development Volunteer in Nicaragua.



Jeanne Goldberg, EEOC Deputy General Counsel, Washington, DC

Previously, she served for 20 years as a Senior Attorney Advisor in the EEOC's Office of Legal Counsel. She has delivered hundreds of training presentations throughout the country for private and public sector attorneys, managers, employees, and human resources staff on a wide range of EEO issues and has been a frequent speaker at national conferences. She is also a past Public Co-Chair of the National Programs Committee of the American Bar Association's Section of Labor and Employment Law, and a past government fellow on the Section's Equal Employment Opportunity Committee. Prior to joining the EEOC, Ms. Goldberg was in private law practice from 1990-99, specializing in civil rights litigation, and argued EEO cases before the U.S. Courts of Appeals for the Fourth and D.C. Circuits. She also served as an adjunct law professor at the College of William and Mary from 1996-98. Before entering private practice, she worked for two years as a staff attorney for the U.S. Court of Appeals for the Third Circuit. She received her B.A. from Northwestern University and her J.D. from George Washington University.
